Important update on Blood Pressure Check Service: IT system update

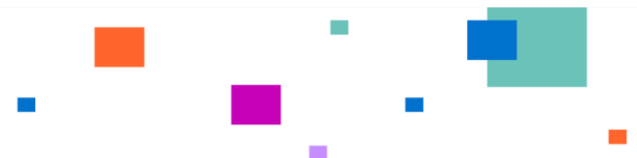
The NHSBSA are currently working with clinical pharmacy system suppliers to assure their Blood Pressure Check Service modules, including the APIs. The target ‘go live’ date for the modules and API is 1 September 2023. Use of one of them will become mandatory and the existing manual MYS claim process for the service will be retired.

It is expected that all payment claims for the service from 1 September will need to be made via the API and there will be no manual option to claim for service provisions. Pharmacy contractors that are registered to provide the service will need to use an approved clinical system to make their clinical records and payment claims for the service from 1 September. All service provisions within June, July and August 2023 must be claimed by the current manual MYS process by Tuesday 5 September.

If you are part of a pharmacy group or multiple, please liaise with your company managers/head office before actioning.

NMS quarterly	Voluntary	14/07/2023	<p>Community Pharmacy England (CPE) have agreed with NHS England that the quarterly returns will initially be on a voluntary basis with Q4 (January to March 2023) as the next quarter to be reported. CPE has also agreed a longer than usual submission period over which submissions can be made.</p> <p>Voluntary submissions can be made via the NHSBSA website, where an updated reporting spreadsheet is also available for head offices to use who are able to submit data on behalf of multiple pharmacies.</p>	
Community Pharmacy Assurance Framework (CPAF) screening questionnaire	Compulsory	3 rd July -30 th July 2023	<p>Pharmacy contractors should have received communication from NHSBSA that the CPAF screening questionnaire went live on 3 July 2023 and will be available for completion until midnight on 30 July 2023.</p> <p>Users of the NHSBSA’s Manage Your Service (MYS) portal will be able to complete this year’s CPAF by logging in. Contractors who are not yet signed up to MYS will be able to complete the questionnaire online and will have received email details on how to do this. Completion of the screening questionnaire is compulsory, and the results of the questionnaire will form the basis upon which contractors will be asked to complete the full CPAF survey and may receive a contract monitoring visit later in the year.</p>
