Pharmacy Technician Workforce Expansion Expression of Interest (EoI)

Once you have reviewed the guidance, and where applicable, formed your partnerships for a multi-sector submission, please complete the <u>online Eol</u>. This form will not open until Monday 7 August, 09:00 and will close on Sunday 17 September, 23:59.

Community Pharmacist Consultation Service (CPCS) IT solution not yet secured. (New)

The national provision of NHS Community Pharmacist Consultation Service (CPCS) IT solutions ended on 31 March 2022. Since 1 April 2022, pharmacy contractors have been responsible for securing a new contractual agreement with an assured IT supplier of their choosing.

Pharmacies identified by PharmOutcomes and the DoS team as **NOT HAVING COMPLETED THE PROCESS** to put a contractual agreement in place have received a sperate email. Please take action immediately to rectify this.

The options are:

- Contact PharmOutcomes if you wish to remain with them and complete the process to put a contractual agreement in place.
- Contact one of the other assured providers and put a contractual agreement in place with them.

Deregister from providing CPCS.

If you do not take action, you are at risk of your current PharmOutcomes CPCS licence being revoked. Please note it is a service requirement (section 3.2): <a href="https://www.ncsen.org/ncsen.org

3.2 Where IT solutions which meet the minimum digital requirements of the service (as specified within the NHS CPCS Technical Toolkit and including an application programming interface (API) to facilitate transfer of data into the NHSBSA MYS platform) are available, contractors must utilise one of these systems within the timeframe agreed by NHS England, the Department of Health and Social Care (DHSC) and the Pharmaceutical Services Negotiating Committee (PSNC). When choosing an IT supplier, contractors should refer to the NHS CPCS IT Buyers Guide.

Reducing the cost of OTC prescriptions (Reminder)

As you are aware, NHS Kent and Medway is hoping to reduce the amount of money spent on prescribing over-the-counter (OTC) medicine.

Last year, we spent £18million on items which could have been brought by patients from a supermarket or pharmacy.

To help try and reduce OTC spend and free up pharmacy time, the ICB is sending pharmacies and GP practices in the highest prescribing parts of **East Kent** patient material aimed at reducing the most frequently prescribed medication. These posters should arrive in the next few days.

Shortage of GLP-1 RAs - key points for community pharmacies (Reminder)

- There are very limited, intermittent supplies of all GLP-1 RAs licensed in the management of T2DM.
- National Patient Safety Alert (NPSA) requiring action by the 18th October 2023.
- Supply is not expected to return to normal until at least mid-2024.
- The supply issues have been caused by an increase in demand for these products, for both licensed and off-label indications.
- GLP-1 RAs should only be prescribed for their licensed indication not off-label use for the management of obesity.
- Do not initiate people with type 2 diabetes mellitus (T2DM) on GLP-1 RAs for the duration of the GLP1-RA national shortage.
- Avoid switching between brands of GLP-1 RAs, including between injectable and oral forms.
- Where a higher dose preparation of GLP-1 RA is not available, do not substitute by doubling up a lower dose preparation.

- Do not prescribe excessive quantities one month at a time. Ozempic: one pen has 4 doses, which is 4 weeks supply.
- Order stocks sensibly in line with demand during this time, limiting prescribing to minimise risk to the supply chain, whilst acknowledging the needs of the patient
- Clinical Guidance to support in choosing suitable alternative glucose lowering therapies, during the national shortage of GLP-1 RAs:
 Joint PCDS and ABCD guidance: GLP-1 receptor agonist national shortage NICE NG28 Type 2
 Diabetes in Adults: choosing medicines
- It is important to note that specific brands of insulin mentioned within NICE NG28 are
 unlikely to be able to take a large uplift in prescribing, therefore any decisions on insulin
 brand choice should be based on ongoing insulin availability noted within the SPS Medicines
 Supply Tool: Prescribing available insulins SPS Specialist Pharmacy Service The first stop
 for professional medicines advice.
