Hypertension Case-Finding Service: Commencement of PPV activity

From the 9th of October, the NHS Business Services Authority (NHSBSA) Provider Assurance Team (PAT) will conduct post-payment verification (PPV) reviews of pharmacy owners offering the Hypertension Case-Finding Service. These reviews, commissioned by NHS England, will look particularly at pharmacies claiming for high volumes of blood pressure checks-

Community Pharmacy England has sought to ensure the verification process is appropriately targeted, proportionate and fair to those pharmacy owners asked to provide records. We encourage the selected pharmacy owners to fully engage with the NHSBSA PAT and provide the evidence requested through the PPV process.

Community pharmacists and pharmacy technicians are being offered a range of fully funded, flexible training to expand your clinical skills and improve patient care.



Dispensing of valproate-containing medicines (New!

Changes to the Human Medicines Regulations 2023 came into effect on the 11th of October which provides new rules requiring pharmacists to dispense all licensed medicines containing valproate in the manufacturer's original full pack.

The Medicines and Healthcare products Regulatory Agency (MHRA) published <u>new</u> guidance for dispensers to support this change.



MYS dashboard updates (New!)

The NHS Business Services Authority (NHSBSA) has announced that from the 12th of October, the layout of the Manage Your Service (MYS) dashboard will be updated based on user feedback. The changes include moving the current tabs to the left-hand side of the page and reordering them in alphabetical order.

NHS Kent & Medway Emollient Prescribing Guidelines and Position Statement on Bath and Shower Preparations (New!)

In 2022/23, NHS Kent and Medway spent over £2million on emollients and £265,000 on bath and shower products.

To support the self-care campaign and in line with the latest update to NICE CG57, NHS England guidance, and the BATHE Study, NHS Kent and Medway will be releasing a position statement for bath and shower preparations stating, "bath and shower products should not routinely be prescribed" and patients should be advised to purchase should they wish to use these products.

In addition, NHS Kent and Medway have prepared guidance on prescribing of emollients outlining that emollients should only be prescribed for the management of diagnosed dermatological conditions, such as eczema or psoriasis; or where there is a significant risk to skin integrity in the prescriber's clinical assessment. The Epimax® range is the preferred choice for patients in Kent and Medway but should these not be effective, there are other cost-effective products included in the guidelines.

The guidelines and position statement will be implemented across Kent and Medway by December 2023 and further communications will be sent out.
