We invite you to submit an expression of interest to join the NHS England Pharmacy Workforce Group for Genomics!

The pharmacy workforce play an integral role in the realisation of personalised medicine and medicines optimisation driven by genomic and diagnostic characterisation. As the NHS Genomic Medicine Service (GMS) evolves and becomes embedded across clinical specialties we need to ensure we have a multiprofessional workforce ready to deliver the service for the benefit of patients and their families. In addition, the government strategy 'Genome UK:

The Future of Healthcare' highlights the need for all pharmacy staff to have a knowledge of genomics relevant to their role, and the recent NHS England "Accelerating Genomic Medicine in the NHS" strategy begins to capture when and where pharmacy will support the delivery of genomic medicine to patients, to

ensure they get the best outcomes from their medications.

The NHS England Genomics Unit, working jointly with the NHS England National Genomics Education programme, established the Pharmacy Workforce Group for Genomics in 2021 to drive forward key workforce priorities to embed genomics into pharmacy practice.
