Thank you for all the fantastic work supporting patients over the bank holiday weekend, this has been a tremendous benefit to our patient population.

We have a couple of action points to help continue effective service provision:

- Please ensure we are communicating referral capacity with local surgeries. This regular communication helps support good patient experience.
- Inappropriate referrals for conditions that fall outside of the service specification - such as chest infection should not be actioned as part of the pharmacy first service. Please ensure that such referrals are rejected and this information is fedback to the surgery so that the patient can be seen promptly by another service provider. If a surgery requires further training or support with referrals into the service please encourage them to contact the LPC for training – admin@kentlpc.org.uk

Prescription charge to rise to £9.90 on 1 May 2024 (NEW)

The Department of Health and Social Care (DHSC) has announced that from **1st May 2024**, the NHS prescription charge will **increase to £9.90 per prescription item** (note: some items may incur more than one charge). For **prescriptions dispensed in April 2024**, the NHS prescription charge will remain at £9.65.

Change of Postal Address for SE Complaints Hub (New)

As you will be aware, there are two ways people can make a complaint about GPs, dentists, optometry practices or pharmacies:

They can complain to the healthcare provider: this is the organisation where they received the NHS service, for example a GP practice, a dental practice, a community pharmacy or an optometry practice **or** They can complain to the commissioner of the service: this is the organisation that paid for the service or care they received.

In the South East, complaints made to the commissioner are managed by

the South East Complaints Hub which is hosted by NHS Frimley ICB and works on behalf of the ICBs in the South East.

In February 2024, NHS England published <u>'Report of a UK survey of</u> <u>pharmacy professionals' involvement in research'</u>. Supported by the four UK chief pharmaceutical officers, the report sets out recommendations to embed a research culture in pharmacy careers, develop a clinical academic pathway for pharmacy and provide a pipeline of pharmacy research leaders.

The recommendations are for all UK nations. and cover themes including research training, mentoring, engagement, and protected time. While these recommendations were developed to be as inclusive as possible, it is recognised that the pace and order of implementation may vary across the devolved administrations, to suit the national context.

Only a minority of pharmacy professionals are research-active, and they are under-represented in clinical research compared to other healthcare professionals.

It's important that both pharmacists and pharmacy technicians have the opportunity to take part in research.

Applications are open until 17 April for expressions of interest from pharmacists and pharmacy technicians to join the Pharmacy Research Advisory Group (PRAG), a new group tasked with advising on the implementation of these recommendations,

which will be co-chaired by David Webb, Chief Pharmaceutical Officer for England and Professor Christine Bond, Emeritus Professor (Academic Primary Care), University of Aberdeen.

ADHD Medicines Supply Disruption update 02.04.24 (New) Message from the K&M ICB on ADHD medicine supply to GPs.

Some key points regarding the shortage:

- Even with the dates stated, it may take time for supplies to reach the front line.
- The stock situation remains fluid so please do speak to patients to understand their current supply.
- The national advice is not to start new patients on any affected products until the supply situation resolves.
- Non-pharmacological advice and coping strategies can be suggested to patients who are impacted by the supply disruption, the specialist services will have expertise in this area.

In light of the Medicine Supply Notification (MSN): Lisdexamfetamine (Elvanse®) capsules, primary care and community pharmacy teams should:

- Work collaboratively to understand local stock availability of alternative strengths and issue a prescription to make up the required dose if possible;
- Check the SPS <u>'Prescribing available medicines to treat ADHD'</u> page for up-to-date information on availability of Elvanse capsules and anticipated resupply dates;

- Ensure lisdexamfetamine is prescribed on a separate prescription (FP10) or an electronic prescription. Do not send the electronic prescription to the nominated pharmacy unless it has been confirmed that the medicine is in stock at that pharmacy
- Consider prescribing unlicensed products only where licensed alternatives are not appropriate.
- Prescribers should work with local pharmacy teams to ensure orders are placed within appropriate time frames as lead times may vary; and if the above options are not considered appropriate, advice should be sought from specialists on management options.

We appreciate that the supply disruption will cause anxiety for patients and their families, a reminder that NHS Kent and Medway has set up a non-clinical helpline for patients who would like more information on the supply disruption (01634 335095 option 3 then option 3, ADHD Medicine Shortages). This may help you to support the messaging for patients.

A gentle reminder that community pharmacies will ONLY be able to dispense what is written on the prescription, therefore new prescriptions will be needed for changes to the drug/dose/strength. This is a legal requirement, please bear this in mind. A phone call to local pharmacies to understand stock levels prior to prescribing is recommended.
