community pharmacies and has good understanding of our sector. She has already made a positive impact since joining the LPC.



Pharmacy contraception service de-registration

Following conversations and agreement with NHS England, in response to queries from pharmacy owners and some LPCs regarding pharmacies that were de-registered from the Pharmacy Contraception Service, the NHBSA has sent the <u>attached</u> communication, by email, directly to all 381 pharmacies that were de-registered from the service, to offer them the chance to re-register.

£9.90

per item

Prescription charge to rise to £9.90 on 1 May 2024 (Reminder)

The Department of Health and Social Care (DHSC) has announced that from **1st May 2024**, the NHS prescription charge will **increase to £9.90 per prescription item** (note: some items may incur more than one charge). For **prescriptions dispensed in April 2024**, the NHS prescription charge will remain at £9.65.

CPPE learning opportunity for Community Pharmacy technicians

CPPE Pharmacy technician impact groups – now open for bookings!

CPPE have a limited number of places on three pharmacy technician impact groups starting in May 2024. These are a series of small group sessions designed to support pharmacy technicians to build their confidence and develop their leadership skills further. They enhance the ability to undertake a professional approach to practice and lifelong learning. They also provide a networking opportunity with other pharmacy technicians in practice.

The sessions run over a 12-month period where groups meet six times at approximately eight weekly intervals. They are facilitated by a CPPE tutor who is specially trained in an action learning approach. The impact

groups are open to any pharmacy technician in England, in any sector of practice, who deliver or support the delivery of NHS Services.
