Pharmacy contractors should soon receive confirmation from NHSBSA that the CPAF screening questionnaire will go live on **1 July 2024** and will be available for completion until midnight on **31 July**.

Users of the [NHSBSA's Manage Your Service \(MYS\)](#) portal will be able to complete this year's CPAF by logging in. The very small number of contractors who do not have a sign in for MYS will be able to complete the questionnaire online and will receive email details on how to do this.

Completion of the screening questionnaire is compulsory, and the results of the questionnaire will form the basis of which contractors will be asked to complete the full CPAF survey and may be visited later.

Pharmacy technicians now added to PGD legislation in England

Following the consultation earlier in the year, the Human Medicines Regulations 2012 have now been updated to add pharmacy technicians to the list of professionals able to supply and administer medicines via PGD which can be viewed [here](#) Patient group directions: who can use them - GOV.UK (www.gov.uk). These changes will be in place and the list updated after 26/06/2024.

This presents an opportunity for the pharmacy technician profession to play a greater role in supporting patient care and capacity for clinical services and is a real opportunity to further build on the skill mix within teams. This is particularly important as we prepare for independent prescribing to be a mainstream part of pharmacist roles in future, across all sectors.

For community pharmacy, this presents an exciting opportunity for pharmacy technicians to further support clinical service provision and patient care, particularly around new and upcoming clinical services- subject to this being permitted within service specifications.
