Important deadlines for COVID vaccination site only

- **1.** You must complete a one-time acknowledgement page in FDP supply dashboard by 13th September for vaccine deliveries w/c 23rd or 30th September.
- 2. From 2nd 13th September- new sites will be added to O-Flow
- 3. From 16th September sites need to add their availability
- 4. 23rd September- NBS will open to the public.
- **5.** 3rd October- appointment booking starts.




Notifying unplanned temporary suspensions of pharmaceutical services via NHSBSA Manage Your Service (MYS)

A module has been released to the MYS platform that enables contractors to notify their ICB of any temporary closure of their pharmacy instead of using the paper form or emailing the information to ICB pharmacy teams.

Using the MYS module will automatically ensure that pharmacy contractor notifications are sent directly to the relevant ICB, and will also enable the contractor to see a record of any submissions that have been made via MYS. Currently, use of the module is voluntary.

ICBs will receive reports of submissions multiple times a day so they are aware of any service suspensions in their area.



Amendment to NHS (Pharmaceutical Services) Regulations

Amendments to the NHS (Pharmaceutical Services) Regulations have been laid in parliament. This means that from 1 October 2024, any applications made to the Pharmaceutical List will no longer require provision of details of suitable referees, and references will no longer be sought in relation to applications.

Any applications made before October will still have to provide the details of referees as before. The amendments can be viewed here. Other amendments to the Regulations relating to the provision of drugs are also included and come in to force on 1 January 2025. Contractors should ensure they are familiar with the changes.



An evaluation of oral anticoagulant safety indicators by England's community pharmacies

Anticoagulants are life-saving medicines that can prevent strokes for patients diagnosed with atrial fibrillation as well as treating patients with venous thromboembolism, but when used incorrectly, they are associated with patient harm. In 2021-22 and 2023-24, two national audits were incentivised in the Pharmacy Quality Scheme to understand the impact community pharmacy teams have on improving anticoagulant safety.

Approximately 11,000 community pharmacies audited just under a quarter of a million patients and made almost 150,000 interventions for patients taking oral anticoagulants. The results found community pharmacy teams are well placed in educating and counselling patients on the safe use of anticoagulants and ensuring that all patients are correctly monitored.

Pharmacy Vape Pilot Sites- Medway Pharmacies

The Government have set an ambition for England to be smokefree (<5% prevalence) by 2030, and to achieve this we need 50% of smokers to undertake a quit attempt every year.

E-cigarettes are effective stop smoking aids. When combined with face-to-face behavioral support, e-cigarettes are *twice as effective* in supporting smokers to quit, and *one fifth of the cost* when compared to other nicotine replacement products such as patches or gum.

Rivaroxaban Tablets Reimbursement Changes

Starting this month, Rivaroxaban tablets (2.5mg, 10mg, 15mg, and 20mg) will be reclassified outside of Category C, impacting their reimbursement. Prices will now be based on generic products, calculated using supplier data under the Health Service Products (Provision and Disclosure of Information) Regulations 2018.

Branded prescriptions will continue to be reimbursed in line with the NHS list prices of Xarelto®.
