Global IT Outage

We are continuing to monitor the impact of the outage on Community Pharmacies locally. Note the request for GP connect to be turned off urgently. The message sent to out to GP practices today can be found here.

This only means that completed referrals can be sent back via NHS mail.

You may start to see more FP10 paper prescriptions today so do plan for this accordingly.

The current update from NHSE is that all pharmacies should be up and running but various systems might be slow or down mainly the cloud-based systems. NHS spine is extremely slow or not working for various pharmacies. There is no need to notify the Pharmacy hub team unless you have to close. In

that case simply submit temporary notices of suspension of service as normal. Forms can be found NHS England » Pharmacytemplateforms.



COVID-19 Vaccinations

A new expression of interest process for pharmacy owners that wish to take part in the COVID-19 Vaccination Service from a location away from their pharmacy and are able to assist with the provision of further fixed sites services and/or outreach vaccination services.


Lateral Flow Device Service

A service finder tool is now available on the NHS website to assist members of the public and healthcare professionals to search for a pharmacy that offers the service.

Pharmacy Contraception Service

Additional promotional resources have been added to the service page, including, a digital poster and a business card leaflet to assist with promotion of the service around university sites, suggested social media messages & text messages and social media tiles.



West Kent Common Ailments Scheme

The West Kent Common Ailments Scheme has been reviewed and a formal decision has been made to decommission the service with effect from Saturday, 31 August 2024.

Contractors will be able to process any outstanding claims on PharmOutcomes until Monday, 30 September 2024, after this time the service will be deactivated on the system. Please submit any invoices for payment by Thursday, 31 October 2024 at the latest.

As the service was only offered in west Kent it has created unintended inequity for the population of Kent and Medway as patients from other areas cannot access the service.

NHS Kent and Medway are encouraging patients to self-care for minor ailments and utilise other means of support such as Pharmacy First which encompasses the Community Pharmacy Consultation Service.

Pharmacy Technician Practice and Policy Strategic Oversight Group

We are pleased to announce that NHS England has established a Pharmacy Technician Practice and Policy Strategic Oversight Group in response to the new legislation that enables pharmacy technicians to supply and/or administer certain medicines under patient group directions (PGDs).

The group will, in collaboration with key stakeholders, consider updating NHS advanced and nationally agreed enhanced clinical service specifications to ensure that the changes to the regulations have the most positive benefits for patients. Implementation plans will consider current arrangements, clinical governance, competency frameworks and appropriate training requirements.

While this work is being done, we are encouraging pharmacy technicians to take part in new learning opportunities including: <u>CPPE Pharmacy technicians:</u> using patient group directions in practice e-learning programme. In addition, please visit the SPS website for resources and information that support pharmacy technicians working under patient group directions.





Community Pharmacy Assurance Framework (CPAF) screening questionnaire (Deadline!)

Pharmacy contractors should soon receive confirmation from NHSBSA that the CPAF screening questionnaire will go live on **1 July 2024** and will be available for completion until midnight on **31 July**.

Users of the <u>NHSBSA's Manage Your Service (MYS)</u> portal will be able to complete this year's CPAF by logging in. The very small number of contractors who do not have a sign in for MYS will be able to complete the questionnaire online and will receive email details on how to do this.

Completion of the screening questionnaire is compulsory, and the results of the questionnaire will form the basis of which contractors will be asked to complete the full CPAF survey and may be visited later.
