


Online Training for Community Pharmacy Teams

Community Pharmacy Assurance Framework (CPAF) screening questionnaire (Deadline!)

Pharmacy contractors should soon receive confirmation from NHSBSA that the CPAF screening questionnaire will go live on **1 July 2024** and will be available for completion until midnight on **31 July**.

Users of the <u>NHSBSA's Manage Your Service (MYS)</u> portal will be able to complete this year's CPAF by logging in. The very small number of contractors who do not

have a sign in for MYS will be able to complete the questionnaire online and will receive email details on how to do this.

Completion of the screening questionnaire is compulsory, and the results of the questionnaire will form the basis of which contractors will be asked to complete the full CPAF survey and may be visited later.



Pharmacist Independent prescribing NHSE funded places at the University of Bath

Applications now open

There will be 2 versions of the course, one hybrid with 4 days on campus at Bath and 4 days delivered online via Zoom. The other with all 8 days completely online via Zoom.

Applicants will need –

- · A copy of their pharmacy undergraduate degree certificate
- An academic reference this can be from their university tutor. If it is several years since studying at university a second professional reference can be used instead. This should indicate the ability to be able to study at a high level.

• Professional reference – this can be from an educational lead, manager, supervisor of mentor.

• A DPP (designated prescribing practitioner) who will supervise their learning to prescribe in a practice setting. 90 hours of 'practice based learning' is part of the GPhC requirements for pharmacist prescribers.

The DPP must meet the GPhC standard 9.2 which states that prospective

Designated Prescribing Practitioners must have:

• Active prescribing competence applicable to the areas in which they will be

supervising

- Appropriate patient-facing clinical and diagnostic skills
- Supported or supervised other healthcare professionals
- The ability to assess patient-facing clinical and diagnostic skills.

DPPs do not have to have 3 years of prescribing practice. There is a form for the DPP to complete which can be found <u>here</u>.

The university website has a link to the universal university application form which is completed online. There is a second information form to be completed which captures the clinical area the applicant will start their prescribing in and the funding information and the aspects NHSE need us to report on.

MHRA alert: Topiramate (Topamax): introduction of new safety measures, including a Pregnancy Prevention Programme

Topiramate is now contraindicated in pregnancy and in women of childbearing potential unless the conditions of a Pregnancy Prevention Programme are fulfilled. This follows a review by the MHRA which concluded that the use of topiramate during pregnancy is associated with significant harm to the unborn child. See the full alert <u>(here)</u>

The MHRA alert has specified the following advice for dispensers:

- A <u>Patient Card</u> to be given by pharmacists to all female patients who are dispensed topiramate to inform them of the risks
- a visual warning symbol will be added to the pack of topiramate. This symbol will show a pregnant woman in a red circle with a line through it,

with warning text about the risks and information about the new measures

- until warning symbols are present on packs, stickers will be available to print locally on eMC
- pharmacists should dispense in whole packs whenever possible. This will ensure that patients always see the warning symbol and receive the statutory information
- pharmacists should give the patient card to female patients when dispensing topiramate
- ask women or girls of childbearing potential if they are taking highly effective contraception, if they are not, pharmacists should advise them to contact their GP for a follow-up appointment



Whooping cough vaccination in pregnancy communications

Pertussis cases continue to rise rapidly and sadly there have been 9 infant deaths since the current outbreak began in November last year.

The NHS is encouraging staff who come into contact with pregnant women to signpost or offer pertussis vaccination at every opportunity.

Updated Incident Reporting Approved Particulars

<u>New Incident Reporting Approved Particulars</u> have been published to the NHS England website (as of 23 July 2024).

This document will replace the previous Approved Particular which has been in place since 2012. Contractors should familiarise themselves with the content of this new document to ensure they understand what is required should an incident occur, including being familiar with what is considered an incident.
