Pharmacy First Minimum Activity Levels

NHS England and DHSC are keen to support Pharmacies to continue to provide Pharmacy First. Minimum Activity Levels have been reviewed based on early levels of uptake and activity across the country, to ensure continued access for patients.

Following representations from Community Pharmacy England, the Minimum Activity Requirements for the remainder of 2024/25, have been revised downwards and are as follows: 20 in October, November and December 2024, 25 in January and February 2025 and 30 in March 2025



<u>Outstanding patient safety notifications</u> (Urgent action needed if not done so already)

Contractors are being contacted because we have not received a submission from your pharmacy confirming the review of post event messages (PEMs) for clinical services.

Please endeavour to review any outstanding post event messages (PEMs) and submit the MS form confirming either completion, or no PEMs, as soon as possible and no later than Wednesday 30 October.

Please ensure you are working through these in line with the guidance attached to ensure that any notification with a potentially higher clinical risk is dealt with at the earliest opportunity.

The next Webinar date is to be advised. Invites will be sent nearer the time. Please ensure you complete the following Actions.

- Save the link to the Seasonal Vaccination Site Guide AW24 and ensure you are viewing the latest version. Last update 10 October 2024.
- Check your fridge capacity and update if the capacity is zero or too low.
- Ensure you complete regular stock takes as a minimum every 7 days and after every delivery. The more stock takes you do the better.
- Use NBS for bookings and NOT local bookings as this will ensure the TDM will work efficiently.
- Add on Covid only NBS slots as not all patients want co-admin bookings.
- Protect vaccine for booked appointments/care home/housebound use and do not use for walk ins.
- If there is a surge in walk ins please manage the queue and request extra vaccines via the exception process. Please note this will take 3 working days.
- When emailing the team and SVOC please do this courteously. We have had some not very pleasant emails.
- Email the SVOC with vaccine allocation queries do not phone emergency numbers or team members. Please also include the full site details.



Face to Face event in Kent: Optimising Infection Management 25th November

You are invited to attend the <u>Optimising infection management</u> workshop on <u>Monday 25th November</u>, 7pm -9pm at the Holiday Inn, Wrotham Heath, <u>Maidstone at the junction of the M20 and M26</u>.

This is a great opportunity to network and learn with colleagues across different settings within the local area.

This workshop will help you interpret antibiotic prescribing data for your local

area and identify opportunities for improvement to support delivery of the <u>UK</u> Antimicrobial Resistance (AMR) National Action Plan [gov.uk].

This workshop will also support pharmacy professionals in community delivering the NHS the Pharmacy First service. In this programme, we briefly look at local prescribing data. We recognise this may not be a significant part of your role; however, the workshop will allow you to explore red flag symptoms and self-care advice for sinusitis and urinary tract infections using personcentred scenarios. The workshop will also provide a great opportunity to network with colleagues across primary care to tackle antimicrobial resistance as part of a system-wide approach.

<u>Provision of the NHS lateral flow device tests supply service for patients potentially eligible for COVID-19 treatment</u>

NHS lateral flow device tests supply service for patients potentially eligible for COVID-19 treatment (LFD) (via the NHS Business Services Authority's (NHSBSA)

MYS portal) should be available at your pharmacy if you have signed up to the service.

The NHS service finder tool can be used to find the nearest pharmacies that provide the service. This link is as below alongside the service specification.

Following the publication of <u>updated guidance by NICE</u> on 13 March 2024, additional patient groups are now eligible for COVID-19 treatments and in line with the recommendations, NHS England expanded access to NHS LFD testing from 1 April 2024. The full eligibility criteria are:

- People aged 85 years and over
- People with end-stage heart failure who have a long-term ventricular assistance device
- People on the organ transplant waiting list
- People resident in a care home who are aged 70 years and over
- People resident in a care home who have a BMI of 35 kg/m2 or more
- People resident in a care home who have diabetes
- People resident in a care home who have heart failure
- People currently in a hospital who are aged 70 years and over
- People currently in a hospital who have a BMI of 35 kg/m2 or more
- People currently in a hospital who have diabetes
- People currently in a hospital who have heart failure

The pharmacy contractor should satisfy themselves that:

- the patient is eligible to receive LFD tests as set out in the NICE guidelines
- it is providing tests to potentially eligible patients at appropriate intervals

 requests do not exceed what is deemed reasonably required for an eligible patient.

Eligible patients should only receive one box of five LFD tests per consultation. Pharmacies will continue to order LFD tests through their usual suppliers. Please make sure your pharmacy NHS Profile Manager is updated to show the service is available. If your pharmacy is no longer able to deliver the LFD service please make sure you de-register via the NHSBSA Manage Your Service (MYS) portal to save any further confusion.

Please share the service information and criteria with your pharmacy team to be assured incorrect messaging is not being relayed to enquirers.
