

<u>Pharmaceutical Needs Assessment for Kent Health and Wellbeing Board</u> (<u>KWB)</u> for Kent Community Pharmacy Contractors Only

Kent County Council (KCC) is currently developing a revised Pharmaceutical Needs Assessment (PNA), which is a legal requirement every three years and statutory responsibility of the Kent Health and Wellbeing Board. The PNA will be used by NHS England, Kent County Council (KCC), and the Integrated Care Boards to decide whether to approve the opening of new pharmacies and inform commissioning decisions related to other services that could be delivered by pharmacies and other providers.

We would be grateful if you would answer some questions about your pharmacy and the services it provides.

## ADHD Medicines Supply Disruption update 20.11.24

**Attached** below is the latest information on the ADHD medicines supply shortage, including updates to the clinical information and re-supply dates.

The ICB have had reports of patients being switched between brands of methylphenidate prolonged release. In some cases, this has had an adverse effect on patients. Before switching brands, please refer to "Methylphenidate modified-release bioequivalent alternative" table included in the attached supply update. Please refer to specialist service if required

The National Recruitment System will open in January-February 2025 for employers to submit their training programmes for 2026/27 trainee pharmacists.

## Central flu procurement and supply – call for provider engagement

The <u>NHS England Vaccination Strategy</u> set an ambition to improve the efficiency and responsiveness of vaccine supply. As part of this, the aim is to explore the potential costs and benefits of centralising the procurement and supply of adult flu vaccine.

NHS England want to hear from providers of the adult flu vaccination service about the current procurement model and how this supports delivery of the flu programme. Providers are invited to complete <u>a questionnaire</u> which takes 15-20 minutes and is anonymous. The deadline for completion is close **Tuesday 17 December 2024**. Thank you in advance for taking the time to provide feedback.



## QIV-HD, a first line vaccine for the 65 yrs and over is available to order

In line with Joint Committee on Vaccination and Immunisation (JCVI) advice and as stated in the <u>national flu immunisation programme 2024/25 letter</u> flu providers should always use the best available flu vaccines. QIV-HD, a first line vaccine for the 65 yrs and over cohort is available to order from Sanofi. To place an order please contact Sanofi on 0800 854 430 (select option1).

Please note that an alternative second line vaccine should only be used if there is no first line vaccine available to order. Providers are advised to rearrange clinics or signpost people to alternative providers until they have a first line vaccine available.



## Empower your patients with the NHS App!

Patients can now order their repeat prescriptions quickly and securely via the NHS App.

This should reduce prescription queries by enabling patients to track their medication requests. The app also help patients access trusted NHS services, health advice, and their medical records anytime.

Make the NHS App part of your patient conversations – it's a simple tool that can improve access to care and save time for both patients and pharmacy teams.

## Service case study: Medway vape pilot

Seven community pharmacies across Medway are participating in a pilot to include vaping (e-cigarettes) as a treatment option within their locally commissioned stop smoking service.

Community pharmacy smoking cessation advisors will provide eligible patients with a voucher for a starter kit and a supply of up to four weeks worth of vape liquid. E-cigarettes will then be obtained directly by the patient, using a voucher code system from a provider selected by the Medway Public Health Team.

## Engaging with the NHS 10-Year Plan: Join CPE webinar

Community Pharmacy England will be hosting two webinars to discuss the Government's NHS 10-year plan and to help pharmacy owners or others who want to feed into it.

Last month the Secretary of State for Health and Social Care launched a <u>national conversation on the NHS</u>, seeking input and ideas to shape the future of a reformed health service via the <u>change.nhs.uk</u> portal. Healthcare organisations including Community Pharmacy England have also been invited to make formal submissions and support policy working groups. This is all aimed at informing a 10-year plan for the NHS.

Reminder of the requirement to complete the 2024 workforce survey, which is a **mandatory requirement**. The NHS Business Services Authority sent an email to pharmacy contractors containing a link to the survey in October.

In some cases, for example, if you work for a multiple pharmacy group, the survey may be completed centrally. If you are not sure whether the survey should be completed at pharmacy level or by your head office team, please ask your head office team for guidance.

The survey will close at midnight on Wednesday 11th December 2024.
