Emergency contraception and the PCS

The main changes to the service are the addition of oral emergency contraception and the ability of pharmacy technicians to provide the service. On the night, the Services Team will talk attendees through the changes in advance of the scheduled implementation date on 29th October 2025. Enabling pharmacist flexibilities when dispensing medicines - consultation

The Department for Health and Social Care and NHS England have launched a consultation seeking views on proposals to enable pharmacist flexibilities when dispensing medicines.

Proposals include amending the Human Medicines Regulations 2012 to increase pharmacist flexibilities when dispensing medicines by enabling pharmacists working in a community pharmacy to supply a different strength or formulation of the same medicine originally prescribed, in certain circumstances. Childhood Flu Vaccination Service

NHS England has approved and published the <u>patient group direction (PGD)</u> for the new Childhood Flu Vaccination Advanced Service, which is due to launch on **1st October 2025**. This follows the publication of the service specification a few weeks ago.

<u>Update your NHS profile information for flu and COVID-19 offers including walk in options</u>

Community pharmacies are reminded to review and confirm their NHS profile information by 30 September 2025. This process ensures the accuracy of information displayed on the NHS profile and within the Urgent and Emergency Care Directory of Services, and supports preparations for the upcoming autumn and winter vaccination programme.

Pharmacies must use the NHS Profile Manager to verify and confirm contact details, facilities, opening times, and services. Service lists should be updated to reflect current flu and COVID-19 vaccination offerings, including age cohorts and booking methods including walk in options. <u>Updates to NHS Pharmacy First Service clinical pathways, patient group directions and protocol</u>

Following a clinical stocktake, updates have been made to the NHS <u>Pharmacy</u> <u>First</u> Service clinical pathways, patient group directions (PGDs) and protocol to recognise the level of care and workload required to safely and efficiently manage patients. In anticipation of these changes coming into effect from

Wednesday 1 October 2025, the <u>updated service documents have been</u> <u>published</u>.

IT suppliers plan to update their systems overnight on Tuesday 30 September 2025 to allow contractors to record consultations appropriately and in line with the changes. The current service documents will remain in place until 11:59pm on Tuesday 30 September 2025, and are available on the NHSBSA website. Community pharmacy teams providing the NHS Pharmacy First Clinical Pathways should read the updated documents and sign the PGD and protocol authorisation sheet(s) in preparation for go-live. ultations. The webinar will be of interest to clinicians working in primary care settings, including out of hours services and community pharmacy.
