2026/27 seasonal vaccination service specification for community pharmacy contractors

The [2026/27 COVID-19 and adult influenza vaccination advanced service specification](#) has now been published.

For the first time the COVID-19 and adult influenza vaccination service specifications have been combined into one document, although contractors can still sign up to deliver adult influenza vaccinations only.

A [letter has been cascaded and published](#) setting out the key changes, funding, sign up process and deadlines. This letter also details government's [acceptance of the recommended spring 2026 COVID-19 vaccination cohorts and timing](#). Communications about the two-three-year-old flu vaccination service will be separate, pending the outcomes of the evaluation of this year's pilot.

Legislation Change

New legislation has come into force on the 7th January, allowing pharmacy teams to hand out checked and bagged prescriptions to patients or their representative in the absence of a pharmacist. This allows the collection of prescriptions when the pharmacist is temporarily absent, e.g. they are delivering services in the consultation room or taking a break.

This allowance is optional and is at the discretion of the pharmacist, including deciding on which items still need to be handed out under their supervision e.g. cold items, CDs, high risk medicines etc.

The pharmacist can give verbal or written approval for each team member who they authorise, and they can add or remove approval as and when they see fit. There is no specific training required for someone to be authorised; however, the pharmacist should use professional judgement as to whether the team member has the appropriate skills and knowledge to hand out prescriptions - keeping patient safety at mind at all times.

PLEASE NOTE – these changes do not replace or override Responsible Pharmacist rules, which remain unchange



Patient abuse poll

Community pharmacy owners are being asked to share their experiences of patient abuse towards them and their teams, and other challenges, as the Community Pharmacy England Committee prepares for its first meeting of 2026.

Pharmacy owners and their teams continue to work hard to support local communities despite mounting pressures, and this is made even more difficult when they face abuse and aggression from frustrated members of the public. More than half of pharmacy staff reported that abuse from patients is a serious concern in the [**2025 Pharmacy Pressures Survey**](#) – and with further reports now received from LPCs, we want to get an accurate updated picture.
